In order to sustain and increase the quality of our products, KFK decides to adopt the Quality Management System (QMS) according to requirements of ISO 9001:2015 standard.

KFK Management therefore decided:

- by compliance with the applicable requirements of the ISO 9001 standard, to ensure that the customer's needs and requirements of the regulatory authorities are known, applied and fulfilled,
- for continuous improvement of QMS, ensuring that the risks and opportunities that may affect the product, company and customers, thereby improving customer's satisfaction.

KFK Management is aware that their employees are the most valuable resource standing behind the company's success, and therefore decided to take continuous care regarding the employee's health protection and safety at work by implementation of Health and Safety at Work Management System according to the requirements of the OHSAS 18001:2007 standard by:

- provision of appropriate resources which ensure that employees, subcontractors and stakeholders are familiar with this policy and in obligation for its enforcement,
- identification of hazards and health and safety risks, familiarizing them to those in concern,
- provision of working conditions and protective equipment so that health and safety hazards will be as less as possible, according to applicable legal regulations,

- application of appropriate laws and regulations dealing with health protection and safety at work,
- striving for continuous improvement of health protection and safety at work system.

As a production company, KFK uses energy and input materials to produce or install its own products, and therefore inevitably affects its environment. To reduce its impact to the environment and that the development of the company, besides other factors, be based on the sustainable development, KFK's Management decides to adopt Environmental Management System according to the ISO 14001 standard, in order to:
